

## Working together to improve school attendance (May 2022)

This guidance did not become statutory from September 2023 – it's anticipated that the date is now September 2024



This guidance has replaced all previous guidance.

#### Early Help Attendance Project

The DFE is funding a project to support improving school attendance in the city. The project is aimed at improving persistent absenteeism and will be delivered to a focussed group of schools.

The project has been commissioned until March 2025.

The Early Help Service will provide some additional capacity to support children and young people who are persistently absent. Two additional teams have been created on a pilot basis. The first team is funded by DFE and will go live on the 30 of January 2024. The second team is expected to go live in the first week of February.

The Team Around the Family (TAF) approach will be used to create multi-agency plans, with the aim of removing barriers to school attendance.

Schools will be a key agency in the TAF and will contribute to all reviews and plans. If appropriate, families referred to the Education Welfare Service can also be included in the project. The EWO will be invited to support the TAF.

Schools included in this project attended a meeting at Toxteth Annexe on Thursday 1 February.

#### "Moments Matter, Attendance Counts"

A national communications campaign about the importance of attendance was launched on 8 January 2024 - targeting parents and carers.

Under the strapline 'Moments Matter, Attendance Counts' it outlines the importance of attendance for attainment, wellbeing, and development as well as signposting to advice for further support.

## Avoidable Absences - Key Points

Publicity around *avoidable absence*-builds upon our city strategy of working to improve margin data.

- This absence is often not complex and can be improved by strengthening school systems and process.
- Mild illness-Designated Attendance Lead (DAL)should be sharing this with parents and staff.
- https://www.nhs.uk/live-well/is-my-child-too-ill-for-school
- All schools should use the publicity materials.
- Remember this is a support first model good relationships are key.

Please print out/post/ and use all posters available and share the "Is my child too ill for school?" guidance as widely as possible.

#### Key actions for Spring term 2024

- Maximise the impact of the DfE campaign by focussing on "avoidable absence".
- Focus on the 92% -95% band. Consider: Within this group, there are many pupils who have had absence of 92% for multiple years. Has avoidable absence been previously authorised? Has the child's absence historically been at the margins of PA?
- Identify odd days at the earliest possible point using individual registration certificates.
- Act to prevent further odd days of absence by meeting/communicating with parents.
- Preventative meetings offering support are a high impact strategy- meetings should be built into your weekly process.
- Book an Attendance Review with Carolyn.harkness@si.liverpool.gov.uk
- Analyse and act upon absence and PA in Reception during spring 2.
- Attend spring briefings and book training.
- Target margin data!

#### DfE Attendance Hubs

The Beacon C of E Primary is to become a Hub school for Liverpool.

- The aim of the school attendance hubs is to enable schools with strong attendance practice to share their approaches with senior leaders in other similar schools to help them to improve attendance.
- The programme is intended for senior leaders with oversight of attendance.
- Commitment from partner schools to engage and make changes to improve their practice is expected for 12–18 months.
- The DfE has stated that there will be 18 new attendance hubs across 6 regions, bringing the total to 32 and will see nearly 2,000 schools helped to tackle persistent absence.
- From direct pupil engagement initiatives like breakfast clubs and extracurricular activities, to improving their processes and analysis of attendance data, lead hub schools provide a range of support to schools that they can tailor to their pupils and families.

## Elective Home Education-update

It is now estimated that 97,600 pupils are educated at home in England (census data summer '23).

There has been a significant increase in the number of children being home educated.

The EHE Team has dealt with 811 applications since September 2023 leading to 628 children now being home educated in Liverpool.

As soon as school become aware that a family is considering EHE contact the EHE team for advice, guidance and an informal discussion.

#### Section 19

Section 19 of the Education Act 1996 places a duty on LAs to make suitable alternative education for children of compulsory school age who cannot attend school because of illness, exclusion or for any other reason.
