#### Key Messages:

The end of autumn term 2022 was particularly challenging for attendance across the city and nationally. The north west had some of the highest rates of scarlet fever, strep A and chicken pox. The absence rates caused by illness were reflected by the increase in authorised absence rates both locally and nationally.

#### Key actions for spring term

- > Analyse autumn data and action plan for specific cohorts and individuals.
- > Analyse and act upon margin data at least weekly.
- > Continue weekly meetings for SA, PA and margin children.
- Start/continue to modify/adapt your school process in response to what worked during autumn term and in response to good practice shared at training.

Be Proactive, Prevent absence .....

#### Government scraps Schools Bill Legislation- What does that mean for attendance?

• During an education committee meeting on Wednesday 7th December 2022, Education Secretary Gillian Keegan confirmed that the Schools White Paper, also known as the Schools Bill, would not progress in its current format.

- The discontinuation of the bill has been long speculated due to months of uncertainty regarding its progress and strong opposition from the education community.
- The attendance elements of the white Paper are expected to continue.
- DEF -Working Together to improve school attendance is the guidance that all schools should now be working from.
- Gillian Keegan said, "We do remain committed to the objectives, the very many important objectives that underpinned the Bill, and we will be prioritising some aspects of the Bill as well to see what we can do."
- <u>The attendance alliance group</u> established by Nadhim Zahawi has not been discontinued. Ms Keegan stated the group will meet in January to continue to take action to 'get children back in school'

It is still expected that the guidance will become statutory in September 2023.

### <u>Ofsted</u>

<u>Ofsted</u> Chief Inspector <u>Amanda Spielman</u> described ongoing school absences as a "deep and concerning problem".

Pupil attendance is running "persistently" lower than before the pandemic after lockdowns broke the "clear social contract" on children going to school daily, an education leader has said.

School closures amid the pandemic broke down the structure and routine of "getting children up and to school every day", she said, as she warned that a minority of families appear to have "lost sight" of the expectation that children should be sent out every morning to be educated in person.

Amanda went on to say "<u>Schools</u> can't be expected to provide education remotely if the parent feels that they would prefer to keep the child at home more of the time."

#### **Child Performance and licencing**

During the festive period there were many enquiries about attendance of pupils taking part in pantomimes etc.

Tracy Moore is safeguarding licensing manager for Liverpool.

Working together to improve school attendance p57 states:

Leave of absence can be granted for a pupil to undertake employment during school hours for the purpose of taking part in a performance.

Legislation sets out that a local authority license must be obtained before a child can take part in a performance.

Schools should be sympathetic to requests for leave of absence supported by a license as long as school remains satisfied that this will not have a negative effect on a pupil's education.

#### <u>Data sharing</u>

Have you signed up to share your attendance data daily with DFE? This will become statutory by September 2023 Approximately 93% of schools have now signed up.

<u>Admissions Process</u> (This information was previously sent out in a Safeguarding E-Briefing) The Local Authority and EWO Service Manager have confirmed that if schools are notified that a child has been allocated a place at their school then legislation states the school should place the child on their roll within 10 days of this letter. (For children transitioning between key stages e.g. primary to secondary then the child should be placed on roll at the start of the new term).

The new school should always have a conversation with the previous setting and gather information, particularly about any safeguarding concerns or risks. Any safeguarding and child protection files should be transferred with 5 days of the child being placed on roll.

Sometimes, despite being allocated a place, a child and family don't actually take up the place. The child refuses to attend or the parent has no intention of sending the child to your school.

In the past some schools haven't undertaken to place the child on roll until the child and parent have attended an admissions meeting and the child then actually attends for the first day at their new school. This practice is at odds with the requirements of the legislation and doesn't best serve the needs of the child. Hence, the child must be placed on roll within 10 days of the Local Authority's notification letter.

We appreciate that some children may quickly become non-attenders and a burden for the school's resources whilst also impacting upon the school's attendance figures. However, the child will be better safeguarded by having these issues addressed by the school rather than not being placed. The school is able to follow its normal robust practices and work with other agencies to challenge and improve the situation.

Placing a child on roll doesn't prevent schools from having an admissions meeting once the parent and child agree to attend. Whilst there are natural concerns with placing a child on roll before the school has seen them, there is a huge benefit to a child's non-attendance being addressed by the school's robust practices.

Addressing this issue should prevent a large number of children being identified as being without a school placement.

## Coding- some key points....

- Reduced timetable coding
  - Code "C" must be used at all times when a child is not expected to attend.
  - Code "X" must not be used at all for a child on a reduced timetable.
  - Reception children on a reduced timetable MUST be reported to the local authority via online notification form.
  - Pupils above SSA (Year 12/13)- it is not necessary to inform the local authority.
- Code I: Illness

•

In the majority of cases a parent's notification that their child is ill can be accepted without question or concern. Schools should not routinely request that parents provide medical evidence to support illness. Schools are advised not to request medical evidence unnecessarily as it places additional pressure on health professionals, their staff and their appointments system particularly if the illness is one that does not require treatment by a health professional. Only where the school has a genuine and reasonable doubt about the authenticity of the illness should medical evidence be requested to support the absence.

 Code N: Reason for absence not yet provided Where absence is recorded as unexplained in the attendance register, the correct code should be inputted as soon as the reason is ascertained, **but no more than 5 working days after the session.** Code N should not therefore be left on the pupil's attendance record indefinitely; if a reason for absence cannot be established after 5 working days, schools should amend the pupil's record to Code O.

## **Best Practice guidance tips**

 Leave of absence should only be granted in exceptional circumstances. Holidays taken during term time **should not be authorised.** All schools should consider if it is appropriate to request a penalty notice from the local authority. Requests must be submitted within ten school days. If all schools do not act consistently then situations arise which are unfair. (For

It all schools do not act consistently then situations arise which are untair. (For example, Primary school fine, Secondary school don't.)

- If you remove a child from roll and the destination is known, an exit form must be completed. (Not just a CTF) If the child has left the school and the school have been unable to ascertain the family's whereabouts a CME referral will need to be completed.
- Your EWO is the school's professional point of contact for all individual attendance and coding queries. Many cases are complex and require knowledge of context and circumstance.
- Consideration of issuing a penalty notice warning. A copy of the updated form can be found <u>here</u>.

#### • Remote Learning:

The DFE do not currently permit remote learning to be attributed with a code that denotes a present mark.

#### • EHE- Elective Home Education

Schools must inform Liverpool EHE Team of all children who are being removed from roll to be home educated. This includes children who are under statutory school age and children who reside in another authority.

#### **Educational Neglect**

Educational neglect continues to be widely discussed by school leaders and wider agencies. A reminder of the information sent in July 2022 can be found below.

#### SIL July 2022 Safeguarding Briefing

Chronic non-attendance at school is 'Educational Neglect' and the responsibility of all agencies who make up the 'team around the child'. Whilst chronic non-attendance may be symptomatic of other forms of neglect and harm, it must be recognised that chronic non-attendance is in itself a form of neglect without any additional factors. As a child's attendance begins to fall, schools and other agencies should always offer the family support through an early help assessment before a referral to children's services for statutory intervention becomes necessary.
